From Milwaukee –

Take 94 West to exit North 164 & South J #294. Exit North 164 & South J and turn left (South). Proceed to the 3rd light, Northview Rd (FT). Turn right (West) on to Northview Rd. Proceed approximately ¼ mile, and facility is on your left (South side). Park in the lot or on the street. Entrance is in the rear.

Important Facts:

1. Teams that have not turned in their SIGNUPTOPLAY roster and USAV numbers for their team will not be eligible to participate. (NO EXCEPTION!)
2. Coaches must sign off on acceptable sign up to play roster before competing in any matches on the first day of the event. Please check in 30 minutes in advance of your first match both days. This will assure the tournament that you are present. This is greatly appreciated!
3. There will not be a coaches meeting, any changes will be provided to you when checking and signing the acceptable sign up to play roster.
4. No food may be brought into the facility or on deck area. Any coolers must be kept in the car/parking lot.
5. Concessions will be provided by the facility.
6. No gum, food, or beverages (other than water) will be allowed in the gym.
7. Gym bags should be put placed on the bleachers or off to the side walls. (DO NOT STORE AT BENCHES!)
8. Neither Center Court nor the Midwest Penguins are responsible for lost or stolen items.
9. **Region up referees will be provided for all matches this weekend!! Coaches please R2 this weekend or remain courtside to assist with any issues during the match.**
10. Please start the warm-up time immediately following the conclusion of the previous match. This is extremely important, so that we may stay on schedule, get all the matches in, and all leave at a reasonable hour!!! Please work together.
11. Teams must provide a down official (R2), scorekeeper, libero tracker, & 2 lines judges.
12. Admission will be \$3.00 per person at the door.
13. Penguin's first aid will consist of band-aids and other basics.

Rules: USA Volleyball rules will be utilized. There will be a tournament directors table set up in the facility. Libero may serve. *We ask teams that have officiating duties bring the completed score sheets to that table before the start of warm-ups for the next match.*

Warm-Ups: Team warm-ups will consist of 2-4-4 prior to their first match of play (2 shared ball handling, then 4 of each team having their court time which includes serving). All subsequent matches will consist of 3-3 (each team will have to serve within the 3 minutes.). The first match of the day will start on time. All matches that follow may run ahead of schedule. It is the responsibility of each team to follow the progress on their next assigned court and be ready to play when the court is available.

Format: Matches will consist of best of 3. The first two games rally scored to 25 points and the third if necessary rally scored to 15 points. All games are win- by 2, no cap.

- **Tie Breakers:** Badger Region guidelines will be followed. Playoff games in tie-break situations going to Gold will consist of one game to 15 points, no warm up time.
