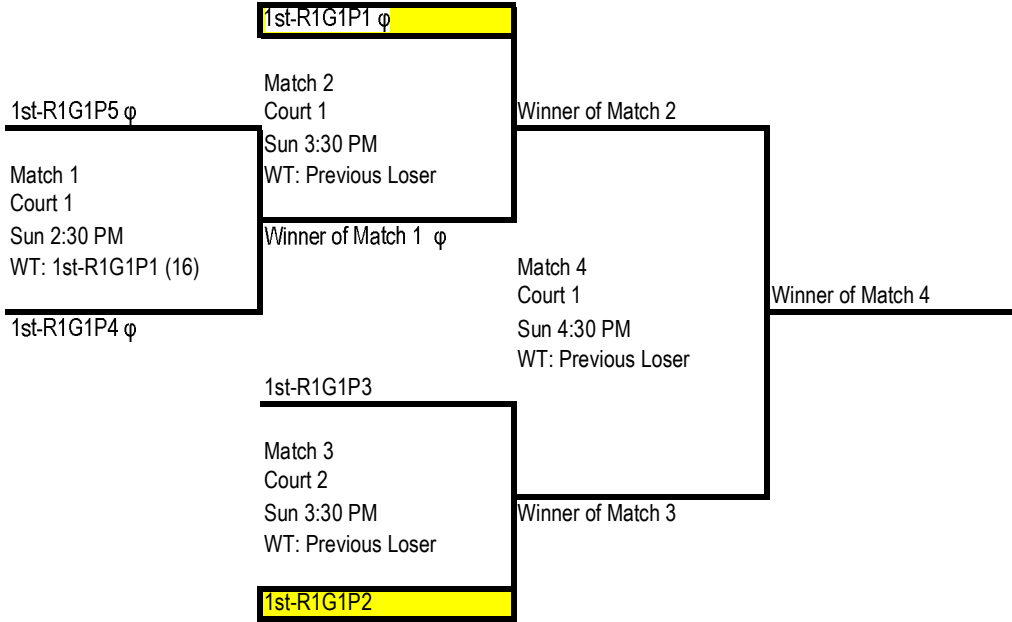

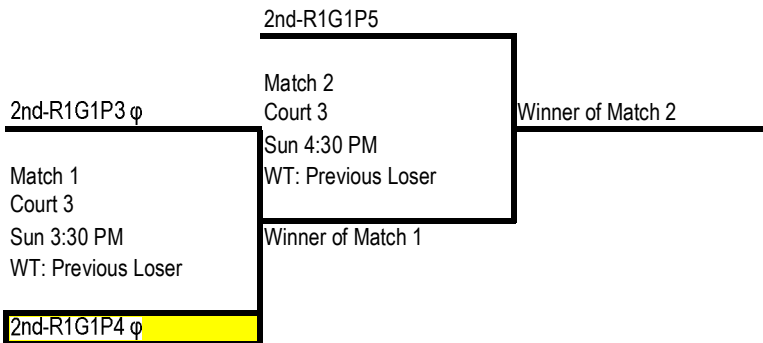

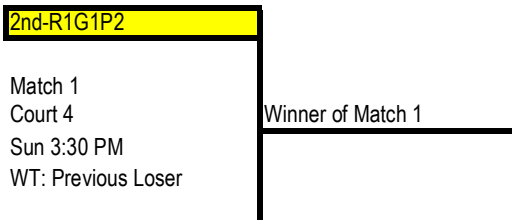

# Tournament Rules and Procedures

## Pool Play Schedule

12:30p	Team 3 v. Team 4 (2)

### Tournament Notes

- Fusion will provide 1st Officials for gold matches. Pool play matches may need to be officiated by coaches but we are working on officials
- Reseeding is pre-determined based on their finish in pool play, for playoffs. Seeding will be determined match %, set %, head to head, point diff, coin toss
- There will be no playoff matches for tie-breaking. The procedures for tie-breaking are above.
- Please review all tournament rules and procedures thoroughly.

### Schedule

- Tournament will begin at 8:30am
- Please consult the schedule carefully to observe match times and officiating duties.
- Officiating teams be especially aware of the first match start time
- We ask that those teams arrive at least 30 minutes prior to the posted match time.

### Rules of Play

- All matches will be 2 out of 3 sets to 25 points, no cap. Deciding set to 15, no cap.

### Officiating Duties

- **We will try to secure 1st Officials for all pool play matches, but be prepared to officiate**
- Team will be responsible for providing 2nd Officials (Down Official), Line Judges, Scorekeepers, and Libero Trackers
- R1 Officials will be assigned for the semi-finals and finals of the Gold Division Bracket

### Warm-Ups

- Warm-ups for the **first two** rounds of the day will be 2 - 4 - 4 (Shared Court - Full Court - Full Court)
- Warm-ups for the remainder of the day will be 4 - 4 (Full - Full)
- Be prepared to play ahead of schedule after first two matches of the day.
- **Please bring your own balls and cart**

### Facility Rules

- The carrying in of any and "all" types of outside food is prohibited at the Fusion Sports Center - Rockford
- Water and Sports Drinks for the athletes are the only items allowed to be carried in.
- No outside chairs are allowed inside the Fusion Sports Center - Rockford, plenty of spectator seating is provided.

### Concessions

- A full and healthy concession stand will be available throughout the day.

### Admission

- There is an admission fee charged to all spectators. The following fees are in effect:
