## Important Facts:

1. Teams that have not turned in their SIGNUPTOPLAY roster and USAV numbers for their team will not be eligible to participate. (NO EXCEPTION!).
2. Coaches must sign off on acceptable sign up to play roster before competing in any matches on the day of event.
3. There will not be a coaches meeting, any changes will be provided to you when checking and signing the acceptable sign up to play roster.
4. No food may be brought into the facility. Any coolers must be kept in the car.
5. Concessions will be provided by the facility.
6. No gum, food, or beverages (other than water) will be allowed in the gym.
7. Gym bags should be put upstairs on the mezzanine. (DO NOT STORE AT BENCHES!)
8. Neither the Center Court nor the Midwest Penguins are responsible for lost or stolen items.
9. Region up ref's will arrive by 2pm for crossover play, based on availability within the Region. Please start the warm-up time immediately following the conclusion of the previous match. This is extremely important, so that we may stay on schedule, get all the matches in, and all leave at a reasonable hour!!! Please work together.
10. Teams must provide an up official (R1), down official (R2), scorekeeper, libero scorekeeper, & 2 lines judges.
11. Admission will be \$2.00 per person at the door.
12. Penguin's first aid will consist of band-aids and other basics. Ice can be received in food area.

**Rules:** USA Volleyball rules will be utilized. There will be a tournament directors table set up in the facility. *Teams that have officiating duties must bring the completed score sheets to that table before the start of warm-ups for the next match.*

**Warm-Ups:** Team warm-ups will consist of 3-3-3-1 prior to their first match of play (3 shared ball handling, then 3 of each team having their court time to attack & 1 shared serving). All subsequent matches will consist of 3-3-1 (3 of each team having their court time to attack & 1 shared serving). There will not be any shared serving time. The first match of the day will start on time. All matches that follow may run ahead of schedule. It is the responsibility of each team to follow the progress on their next assigned court and be ready to play when the court is available.

**Format:** Matches will consist of best of 3. The first two games rally scored to 25 points and the third if necessary rally scored to 15 points. All games are win- by 2, no cap. The event is scheduled to conclude by or near 5:00 pm. If the pool of teams in any division is large, or many playoff games are necessary, the early rounds of playoffs may consist of a single game to 25. The site director will determine whether playoff rounds will be condensed based on the time playoffs will start and considering how many rounds of playoff will be required.

- **Tie Breakers:** Badger Region guidelines will be followed. Playoff games in tie-break situations going to Gold will consist of one game to 15 points, no warm up time.

This process, should allow all the teams to have a minimum of 4 matches, and end the day at a reasonable hour. Any questions, please ask the site directors.
